In place of the Orange County Children's Screening Registry Spotlight Darcie Kass and Traci Stubbler presented on the Inclusion Pathway and its updates, Lisa Edwards will send out the link to everyone.

COMMITTEE REPORTS committees met for 20 minutes to review and discuss

Strategic Planning and Evaluation – Kate Bono, Chair reported that the committee is thinking about what the next steps will be for the Orange County Child Care Strategic Plan is completed. The committee will need to work on the Needs Assessment next year. They have been discussing a better plan for reporting and wrap up of the goals by each committee, it has been decided, and this will be done at the annual LPC Retreat each year. Amber Nowak will be taking over as Co-chair with Kate Bono with Monique Bosse stepping down from Council and moving out of state.

Workforce Development – Susan McClintic reported that due to her resignation from Council, the new Co-chairs would be Lisa Sciabica and Laura Vidal. We had a very successful AB212 (Early Education Career Incentive Program EECIP) this year giving out 179 stipends. Ten (10) people received an AA or BA with the support of AB212, these participants will be recognizing at the OC Excellence in Early Care and Education Awards, being held on Saturday, May 18, 2019. The Committee has started planning the professional development for 2019-2020, beginning with offering The Outdoor Classroom in the fall. The Committee has also agreed to sponsor the Pyramid Module (SEFEL) in an 8 Session, once a month training, contracting with Orange County Department of Education. We are also looking into offering something to continue the Learning Stories and figuring out how we can get a collaboration together. Workforce Development is working on providing a Spotlight on teacher rate of pay. Janet Anderson-Deusenberry reminded members of the awards night, there are still spots available if anyone would like to register to attend.

Inclusion Collaborative – Darcie Kass reported the Inclusion Collaborative Committee is excited about the Second Annual H.E.L.P Conference. This year the focus of the conference will be on how to best support children from special populations. The H.E.L.P Conference on Saturday, September 7, 2019 at Orange County Department of Education using all of the Building D Conference Center we are planning for 300 participants, from 8:00 a.m. to 3:00 p.m. OCAEYC will be handling the registration and marketing, we are currently looking for presenters, and sponsors. We have requested from the Steering Committee the amount of \$5,000 (not to exceed) to put towards translation services, printing, and stipends for presenters. We would like to include parents in the conference this year and have breakouts for administrators. Lisa Edwards will send out the Presenter Proposal Form and Sponsorship Forms to all her distributions lists.

Nominating – Monique Bosse reported that we have a full roster, with a few available spots, which we can continue to recruit for over the year, the categories are well balanced at this point. Monique also shared that Deanna Parga will be taking over as Nomination Chair.

APPOINTED AGENCY REPORT

County of Orange, Board of Supervisors (BOS) - Amber Nowak reported she was selected to represent the Local Planning Council in the California Counts 2020 Census. We want all of our communities to be counted; an accurate count of children under the age 5 has been under counted in the past. There will be 1,400 open positions to work the census. Lisa Edwards will send out the California Counts census information to everyone.

The Early Childhood Policy has a new look and name, it is now called the Early Childhood Framework.

Superintendent of Orange County Schools (SOS) - Chris Becerra reported that we are continually evolving at Orange County Department of Education. We are going to be focusing a lot on working with our school districts making sure that have early childhood education preschool through third grade. Allison Casillas will be moving to Early Learning to take on our new Early Education Inclusive Grant, to insure that districts are providing inclusive education for zero through 5 years old; through this grant, we will be providing free coaching or training. We have also applied for an Early Learning Math grant and should be hearing about that soon, Allison will be overseeing this grant as well.

COUNCIL CHAIR/VICE CHAIR REPORT

- A. Public Policy/Legislation Liaison Report (Fritzi Gragg) Budget revisions came out, not a lot has changed since January, a few things added to the governor budget.
- B. LPC Retreat Diane Montano reported that everyone needs to attend Retreat, registration is required, and at the Retreat, we will be reviewing and planning. Lisa Edwards will send the registration link out electronically so you can register. The theme this year will be "Everyone has a story."

COORDINATOR REPORT

- A. California Transitional Kindergarten Stipend (CTKS) OC Incentive Program status report Susan Shepardson presented this report on behalf of Shelia Arnold. The CTKS grant ended April 30, 2019 this grant began 2014 and over the five years, we have spent \$1,136,562 with the first priority being Transitional Kindergarten teachers and the second priority being California State Preschool teachers.
- B. Voluntary Temporary Transfer of Funds (VTF) Susan Shepardson presented this report on behalf of Shelia Arnold. The VTF is for State childcare funds, any programs that under spent or over spent reports to the Local Planning Council who then makes recommendations to the California Department of Education on where to send additional money in an effort to keep the funds in Orange County. California Department of Education will approve or not approve the complete process; Planning Council's only make recommendations. We had two sites in Orange County that needed additional money and we made the recommendation to California Department of Education that they receive funds.
