OC Children's Screening Registry: Rebecca Hernandez, Help Me Grow OC introduced by Valerie Padilla, Vice Chair, and presented information about the OC Children's Screening Registry and the organizations that were involved in helping put the registry together.

Workforce Development – Laura Vidal, reported that they committee is currently working on the Learning Stories Spotlight they will be presenting at the March Council meeting, also the Community Forum being held on May 20, 2020 after the Council Meeting, they are hoping to invite directors to the Community Forum. There will also be an evening workshop for Learning Stories at Orange County Department of Education, \$25 registration fee; we will be giving out the book "Learning Stories of Practice" to the first 100 people registered. There is a National Conference being held in Michigan at the end of May on Learning Stories, Laura Vidal will be attending. Advocate of the Year Nominations, we received one nomination but the individual does not meet the criteria for nomination, the committee is requesting that members submit a name and brief explanation as to why they are nominating them, send to Sue Bierlich by Friday evening, no forms are needed, just a quick email.

Strategic Planning and Evaluation – Kate Bono reported the committee is working on the Child Care Plan, reviewing the data and is requesting time during the March Council meeting to allow members to continue working on the plan.

Inclusion Collaborative – Traci Stubbler reported that the next committee meeting is March 24, 2020, they are currently in the process of creating an H.E.L.P. Conference planning committee, they will be sending out an email to reach out to Council members for additional help. The Inclusion Pathways continues to need maintenance; Darcie Kass and Janice Howver with the Inclusion Grant are working on getting it cleaned up. The committee will be meeting with Workforce Development Committee regarding higher education and inclusion conversations with students. Is was stated from the members that OCDE is doing a CoP for Department Chairs this may be a good place to bring up this discussion, they meet once a month, Melissa Wheelahan and Krista Murphy are the leads.

Nominating/Membership – The committees first scheduled meeting were cancelled and has been rescheduled for February 27. The committee goals are to revise the Membership Orientation and setting a plan for the year on what the committee is responsible to complete.

APPOINTED AGENCY REPORT

County of Orange Board of Supervisors - Susan Shepardson shared Amber Nowak's report in her absence. The agency Conflict of Interest Form, Form 700 is due April 1, 2020 you should have received an email from the Clerk of the Board, if you do not complete the form by the deadline you will begin being assessed a daily fee of \$10. The Needs Assessment was approved at the last Council meeting. The SELPA numbers and footnotes were added. 85% SMI (State Median Income) was used in some sections and was notated in the footnotes some sections remained at 70%. There was a question about Section 16B Infant Toddler, the section was recalculated, and the need went up to 89% from 28%.

The Priorities Report will go to the Board of Supervisors for approval at the end of March.

Superintendent of Orange County Schools - Debbie Troehler reminded everyone that there is a lot of money for subsidized child care, through the alternative payment program. There will be advertising coming on social media and radio platforms.

Debbie also reported that she will be stepping down as the Superintendent of Schools Liaison and will be transferring the duties to Laura Strachan the Assistant Superintendent in Early Learning, Laura will be at the March Council meeting.

COUNCIL CHAIR/VICE CHAIR REPORT

- A. Public Policy/Legislation Liaison Report (Diane Montano) In Diane Montano's absence, Fritzi Gragg reported that the governor's budget came out, and is being reviewed by legislators. The Governor wants to keep CSPP with the Department of Education and move everything else to Health and Human Services, there are still some questions on how funding will work. Legislators have called out the reorganization stating this could fragment early education.
 - Early childhood OC stated that the Connecting the Tots (mental health program for toddlers) money is going away and Cal Optima would be taking it over within one to two years.
- B. Fritzi Gragg wanted to remind everyone that the standing rules state that council members must attend all Council meetings and must participate in at least one committee. Attendance at committee meetings has gone down.

There are two more Conditions of Children conferences the next one is March 4 for District 4 at Cal State Fullerton focusing on early childhood mental health. District 5 conference will be on April 29 at Mission Hospital focusing on education.

Retreat planning is underway we are looking for committee members to participate on the sub-committee for planning, please email Lisa Edwards or Susan Shepardson if you would like to by on the committee.

COORDINATOR REPORT

A. First 5 Conference Update

Susan Shepardson shared that she attended the First 5 Conference on February 3 – 5 in Irvine. She listened to Pushing the Envelope for Working Families, which was an excellent panel, with the Disneyland Human Resources Director who stated that Disneyland started a child care program for full and part time cast members, for children 12 and under, that helps pay for child care. They have been asked to attend a Council meeting, first 5 is meeting with the them as well, Debbie Troehler stated she would like to discuss OCDE and CHS alternative payment program with them which they could be utilizing.
